# I. President's Annual Report

The following was Professor Xiaoping Cong's Annual Report as CHUS president given at the membership meeting in New Orleans, AHA (January 5, 2013):

Dear CHUS members,

Happy New Year! I wish you all have a productive and promising year in 2013. The CHUS board would like to thank you for your support and trust in the past year. On behalf of the CHUS board, I am honored to submit the annual report to the CHUS community.

In the past year, the Board has accomplished the following tasks and also faced some difficulties. Here is our report:

### 1. Journal

After signing the partnership contract with Maney, CHR has reorganized its editorial board to which Wang Xi continues holding the position of editor with Hanchao Lu and Alan Baumler as co-editor.

In 2012 CHR published two issues—Vol. 19, No. 1 (Spring 2012) and No. 2 (Fall 2012)—which, with a combined 186 pages (text), carried 6 research articles, 2 forum (interview) articles, and 7 book reviews.

### 2. New Members and membership management

In 2012 we have recruited two new members. They are Kevin Landdeck from Sarah Lawrence College and Yang Bin from National University of Singapore. Welcome board.

Thanks to our secretary, Dr. Yinghong Cheng, we have kept updating our record on membership. Dr. Cheng has been frequently sending out reminders to our members for their dues. Moreover, we also updated the template of the membership that provides the newest contact information to the Maney, our journal publisher so that the Maney will be able to mail the CHR journal to each member on time.

### 3. Organizing panels at AHA for 2013

Dr. Danke Li, our organizational coordinator, worked effectively with the AHA to put six panels all together at New Orleans AHA meeting this year. Thanks to Dr. Li for her dedication to continuing serving as a conference coordinator, she will keep working on the panel organization for the next year.

### 4. Status of Registration and Taxation and CHUS' Financial Condition

The board would like to express our gratitude to our ad hoc tax officer, Professor Patrick Shan, who continues offering his time and energy in filing CHUS's tax report to IRS. This year he has finished the tax report and renewed the CHUS registration. With his selfless help, the CHUS continues filing as a non-profit organization and will be able to receive donation without paying tax.

According to the report from our treasurer, Dr. Wang Shuo, based on the bank statements, the fund in our CHUS account was \$13,792.27 by December 31, 2011 and \$17,381.85 by December 27, 2012. It shows a \$3,589.58 increase. In the past year, the total income was \$3,717.81, in which \$2,955.76 was from donations; \$755 was membership fees; and \$7.05 was interests. Our total expenses were \$33.25, in which \$13.25 was paid to CHUS website set-up fees and \$20 to Michigan State as CHUS registration fee. The detail expenses will be listed in the financial report in the newsletter. In the upcoming spring, we are expecting a bill of more than \$3,000 from the Maney which is our due for the members' journal.

Regarding the donation, I want to thank Dr. Patrick Shan (\$100), Dr. Anne Chao (\$1,000) and Mrs. Sherrie Hermann (\$200) for their generous donations. My particular gratitude goes to a number of CHR authors who have collectively donated \$1,156 to the CHUS from their honorarium of publication. Finally, I would like to thank Dr. George Hong for his help that

because of his introduction, we have received \$500 donation from the G-MEO. On behalf of the Board, I would like to thank all donors for their generosity, kindness and support.

### **5. CHUS Newsletters**

Our academic advisor and newsletter editor, Dr. Lian Xi, has composed two newsletters in the last year for the winter issue and summer issue (Issues 63 and 64). Recently, Dr. Lian Xi is making a call for the submission of the members' news, activities and achievements. Please respond to his call so our scholars' excellent works will be known to all members of the community.

### 6. Awards and the Newly Established Graduate Students Travel Grant

The board also organized an evaluation committee for the Academic Excellence and the Distinguished Service awards. Thanks to Professor Wang Di who served the chair of the committee and Professors Pan Yinghong and Lu Weijing who served the committee members. I would like to express my gratitude to their excellent service. Unfortunately, the evaluation committee feels that the nomination pool was too small for a quality competition, thus decides to leave this year's Academic Excellence Award vacant.

Based on the decision of the evaluation committee, the board announces that this year's Distinguished Service Award goes to Professor Zhang Jiayan. Professor Zhang Jiayan served as the CHUS secretary from 2009 to 2011. During his term he devoted a lot of his time and energy to establish a positive image of CHUS, to recruit new members, and to handle routine issues of the organization. His contributions were indispensable to the routine operations of the CHUS. Patrick Shan, former president of CHUS and nominator of Professor Zhang, praises that "Professor Zhang has set an example for his excellent service in our CHUS community. He truly deserves the Award for Distinguished Service, for which he has my highest recommendation."

For the further development of our organization and for promoting the future Chinese scholars and China scholars in the US, the CHUS Board decided to establish a new category of award in addition to the existing two awards. This new award, "the graduate travel grant," will give graduate students more chance for their academic development and for their establishing an academic network. We hope that through awarding this grant, our organization would have a sustainable growth. This grant offers two awardees each year for our student members to travel to the CHUS sponsored panels at the AHA and the AAS. Each recipient will receive maximum \$200 for his/her travel expense only (airfare, hotel, and ground transportation).

In this year of the award, the evaluation committee selected Mr. Yi Guolin, who is a PhD Candidate from the Department of History, Wayne State University, for his attending the AHA, in which he presents a paper "'Here Come the Americans': 'Propaganda State' and Nixon's Visit to China."

The board's congratulations go to all awardees.

### 7. Election

The election for the new board of 2013-15 term encountered some difficulties. The board organized the election committee in last September. Thanks to Dr. Li Xiaobing who willingly

served as chair of election committee, and Drs. Patrick Shan and Shen Yu who served the committee members. We have four positions of the new board which are the president, the secretary, the treasurer, and the newsletter editor. Dr. Danke Li kindly agreed to serve one more term. A call for nomination was made by both the board and the election committee in last September and was also extended twice. Since last September, the election committee has worked very hard to search for candidates for these four positions. However, by December, 2012, we had only two persons who confirmed their willingness to be considered as candidates. Unfortunately, the election committee had no choice but announced an unsuccessful election of this year, thus the board is unable to announce the new board in this meeting.

This is a situation that the CHUS has never met before and our bylaw does not have any instruction on this situation. The current board has made a decision for a new election in early 2013. We would like to show gratitude to the members of election committee for their dedication and service and particularly appreciates the extra efforts they have made in such a difficult situation. The board will organize a new election committee and make a new call for nomination and a new election. According to the bylaw, the current board will continue functioning until the new board elected. Hopefully, with your support and enthusiasm of serving the CHUS, we will have a successful election soon.

In 2012, Professor Ling was honored by the University of Saskatchewan, Canada, as a Role Model Speaker, and by Susquehanna University as the Distinguished Speaker, respectively, to deliver a public lecture entitled "Rise of China and Its Meaning to Asian Americans." She was also selected as a Changjiang Scholar Chair Professor by the Chinese Ministry of Education. ### II. Publication

The spring issue was a special issue, which was guest-edited by Patrick Shan and featured three research articles addressing the history of Chinese frontier in different historical times and locations: Yihong Pan's "Integration of the Northern Ethnic Frontiers in Tang China," Alan Baumler's "Domesticating Regionalism: Northwest China in the War of Resistance, 1937-1945," and Xiaoyuan Liu's "Entering the Cold War and Other 'Wars': The Tibetan Experience." The issue also carries an interview with Professor Ma Dazheng, a senior historian from the Chinese Academy of Social Sciences specializing in frontier study.

The fall issue carries three research articles: Jun Fang's "Literati Statecraft and Military Resistance during the Ming-Qing Transition: The Case of the Possibility Society (Jishe)," Lin Hsiao-ting and Wu Su-feng's "America's China Policy Revisited: Regionalism, Regional Leaders, and Regionalized Aid (1947-1949)," and Yao Zhang's "The Making of the Week That "Changed the World": Nixon's Media Strategy for the U.S.-China Rapprochement." The issue also carries an interview by Ping Yao with Professor Peter Bol from Harvard University, whose databases on ancient Chinese history have generated a lot of impact in the field.

On the whole, our authors include scholars from the United States, China, Taiwan and Canada. Book review authors are even more diverse. The tables for contents for both issues are included in Appendixes

### III. Submissions and Peer Reviews

For 2011, we received altogether 41 submissions, including 32 articles and research notes. The number of submissions increased as compared to 2011. Article submissions reached the highest

since 2004. We believe the two special issues, respectively organized by Lian Xi and Ellen Cong Zhang, have vitally contributed to the increase. Our partnership with Maney Publishing may have been a factor for new authors. See Table 2 for details of the submissions and comparison with the submissions from previous years.

What is not included in Maney's report is CHUS member subscription number, which remains 110 and 10 exchange academic partners and sponsors. Thus, the total subscription number remains at 205.

One striking feature with the 2012 subscription is the availability of online subscription. This new category, which was not available in the previous years, has attracted 36 subscribers, including those that have stopped subscribing the print form of the journal. We consider this as the demonstration of the expected advantage of the partnership with Maney. We cautiously expect the online publication will increase as the journal gradually makes its name.

When we entered partners hip, we gave Maney fiveyear (2007-2011) back issues to be digitize d and placed

online in order to demonstrate the quality of the journal, as well as to attract subscription. The above report reflects some of most popular downloads.

### 3. Marketing

Many has conducted extensive marketing campaigns for CHR throughout 2012 and will continue to do so in 2013. Maney reports that "New institutional subscriptions have mainly come from China and Germany, and we have also seen new subscriptions from our MORE bundles coming

from the UK, USA, Canada and Australia." (Maney Editorial Report, Page 2). In 2013, Maney representatives will attend academic conferences in US and UK, including the Association for Asian Studies Conference.

### 4. Afterthought and Suggestions

Based on the Maney report, we conclude that the first year's partnership with Maney is reasonably successful. CHR has greatly increased its visibility worldwide. Although the total subscription number has not gone up significantly, but the new numbers for online subscription and downloads show great potential of the journal. It is hard, as the Maney report puts it, "gage the popularity of the journal online in just one year," but the online usage after just one year, in Maney's view, "is extremely encouraging and it is clear that subscribers are sing the online archive." (Maney Editorial Report, 1/7/2013)

### A number of suggestions:

- 1. We need to sustain and increase the members' subscription. The current board provided the members' subscription record in a timely fashion so the members could receive the journal on time. It is vital for the board to maintain a viable and updated record of CHUS members and have it sent to CHR at least respectively in April and November so we can provide them to Maney for distribution.
- 2. The board needs to set up the e-links that would provide all members the e-access to the journal online. This is part of CHUS members' privileges we negotiated with Maney. Unfortunately the link has not been set up. We also suggest that CHUS's organizational webpage should highlight CHR on its page to help increase its visibility.
- 3. We are glad to learn that with Maney, both subscription and downloads from China have increased. We need to do more in that regard so the journal would have greater impact in Chinese communities of professional historians.
- 4. We would also encourage the members of the journal's editorial board to activate their e-access to the journal. Starting from 2013, members of the Editorial Board will receive free electronic version of the journal only.
- 5. We need to continue to encourage CHUs members to submit their best research work to CHR.
- 6. We need to encourage all the members of the Editorial Board to recommend good and original research papers to CHR.
- 7. We also need to remind the Editorial Board that the online journal plus archive is available. For now, the Editorial Board subscription activation rate is 21% (low), but the institutional subscription activation rate is 70% and the MORE subscription activation rate is 96%. We want to emphasize again that it is essential to have CHUS members' e-links set up so all members would have online accesses to the journal. This would increase the use of the journal by

members and would subsequently increase the activation rate among CHUS members, which is not counted in Maney's report.
