- Morris L. Bian 卞历南, Associate Professor of History at Auburn University, has translated his book, *The Making of the State Enterprise System in Modern China: The Dynamics of Institutional Change* (Harvard University Press, 2005) into Chinese: 《制度变迁的逻辑：中国现代国营企业制度之形成》，卞历南著，译，浙江大学出版社，2011年5月出版。The Chinese edition is part of a leading translation

series in social and economic history published by Zhejiang University Press (http://www.zjupress.com/book_detail.html?book_id=239461).

- Huaiyu Chen, Assistant Professor, School of Historical, Philosophical and Religious Studies, Arizona State University, received a membership from School of Historical Studies, Institute for Advanced Study in Princeton, for the 2011-2012 academic year.
- Li Chen, Assistant Professor of History and Program Director of Global Asia Studies (2010-2011) at the University of Toronto, has won a four-year Standard Research Grant from the Canadian Social Science and Humanities Research Council for his next book-length project "Confucian Literati as Jurists: Power, Knowledge, and Legal Culture in Late Imperial China, 1610-1910." His article, "Law, Empire, and Historiography of Modern Sino-Western Relations: A Case Study of the *Lady Hughes* Controversy in 1784," *Law & History Review* 27, no. 1 (Spring 2009), 1-53, has won Honorable Mention for the 2011 Law and Society Article Prize for "exceptional scholarship in socio-legal studies" published in the previous two years. A Chinese translation of the same article by Professor Deng Jianpeng and Ms. Song Sini of the Central University of Nationalities of China will be published in the *Peking University Law Review* in summer 2011. He has recently published another article, "Universalism and Equal Sovereignty as Contested Myths of International Law in the Sino-Western Encounter," *Journal of the History of International Law / Revue d'histoire du droit international* 13, no. 1 (Feb. 2011): 75-116. And his article on "Legal Specialists and Judicial Administration in Late Imperial China, 1651-1911" is forthcoming from *Late Imperial China*. His recent presentations include a paper on "Colonial Encounter and Construction of Hierarchy of Legal Cultures" at the annual meeting of the American Society of Legal History in Nov. 2010, and an invited talk on "Visual Images, Imperial Subjectivity, and Intercultural Politics in the Nineteenth Century" as part of "Visualizing Asia in the Modern World" at Harvard University in May 2011. He co-convened a "Roundtable Discussion on the Centenary of the 1911 Revolution of China" at the University of Toronto in May 2011, and organized a panel about "Politics of Imperial Expansion and Rule: Strategies and Challenges of Governing the Frontiers of the Qing Empire in China, c.1700-1911" for the AHA annual conference in January 2012, in which he submitted a paper on "Empire Must Be Defended?: Qing Control of Foreigners in South China."
- Zhongping Chen, Department of History, University of Victoria, Canada, put finishing touches in 2010 on his forthcoming book, *Modern China's Network Revolution: Chambers of Commerce and Sociopolitical Change in the Early Twentieth Century* (Stanford, California: Stanford University Press, forthcoming in July 2011). One of his most recent publications is "The May Fourth Movement and Provincial Warlords: A Reexamination." *Modern China* 36. 2 (2011): 10-45. In addition, he received two federal grants (principal investigator for one project

and co-investigator for another) and presented papers at five academic conferences in Vancouver, Portland, Honolulu (2) and Montreal in 2010-11.

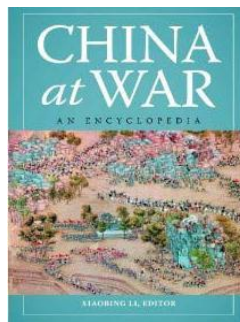

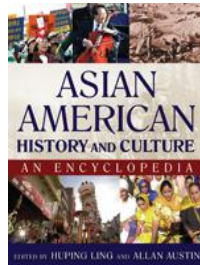
