II CHUS Board Election

Dear CHUS Members:

First of all, we wish all of you a safe, pleasant, and productive summertime.

On behalf of the CHUS community, we want to express our gratefulness to the current CHUS board members, Dr. Zhiguo Yang (President), Dr. Dandan Chen (Secretary), Dr. Xiaojia Hou (Treasurer), Dr. Danke Li (Conference Coordinator), and Dr. Mao Lin (Newsletter Editor and Web Manager), for their dedicated service to this longer term (three years), because our last year's election was delayed for one year until now due to the on-going pandemic.

In particular, we want to thank President Yang for his leadership role in organizing this election committee and for his careful reading our by-laws which will be followed by the election committee to hold this year's election.

The CHUS By-laws Article IV, Section 9 states: "The President and the Board of Directors shall serve for a term of two years. The President may serve consecutively for another term if duly reelected. The members of the Board may serve two more consecutive terms if duly reelected." Among the current board members, Dr. Xiaojia Hou and Dr. Mao Lin have expressed their willingness to continue to serve and they are eligible to stand for this year's reelection. The main duties of those positions are specified below.

President (Article V, Section 2): "The President shall be the Chairman of the Board of Directors and direct and supervise operation of all activities of the CHUS. The President shall divide and assign the duties of the Board of Directors."

Secretary (The Membership Director) (Article V, Section 8): "The Membership Director shall be responsible for maintaining the network of all the members, collecting due membership fees, and recruitment."

Conference Coordinator (The director for public relations) (Article V, Section 9): "The Director for Public Relations shall be responsible for organizing conference panels and projects, writing grant proposals, and other activities related to the public relations of the CHUS."

Treasurer: The Treasurer shall be responsible for receiving and giving receipt of money due and payable to CHUS, and depositing all money in the name of CHUS, disbursing the money and keeping a correct account for the organization.

Newsletter Editor and Web Manager: The Newsletter Editor and Web Manger shall be responsible for collecting information, editing, and publishing the newsletters on a regular basis; and managing CHUS website.

Now, please allow us to call for the nominations or self-nominations for the 2021 CHUS election to form the 2022-2024 CHUS Board.

The Schedule and Deadlines of the 2021 CHUS Election

(1). Nomination. The committee will accept the nominations, including self-nominations, made before the deadline of October 1, 2021. Call for nomination or self-nomination of Academic Excellence Award

Criteria

This year there will be two sub-categories for the award:

--A well-researched and influential MONOGRAPH that was published between September 1, 2020 and September 30, 2021.

--A well-researched ARTICLE published in a peer-reviewed journal between September 1, 2020 and September 30, 2021.

Qualification

--All CHUS members are eligible for consideration of the award with evidence of publications in the form of a monograph or peer-reviewed journal article.

Deadline: October 1, 2021

Method: It can be a nomination or self-nomination

--A candidate can only be nominated for one of the two sub-categories of the award, not both.

- --To make a nomination or self-nomination for either sub-category, please provide:
- 1) a full citation and brief abstract of the book or article:
- 2) a succinct statement on its scholarly contribution to the academic community; and
- 3) an electronic copy of the article or book, if available.

Please email all the above materials to the three members of the Committee for Academic Excellence Award.

Selection Process:

--The Committee for Academic Excellence Award will review the nominated or self-nominated scholarship, and discuss and evaluate their academic contributions. The committee will make its recommendation for each sub-category to the CHUS Board by November 15, 2021.

--The CHUS Board will decide the finalist for the Award by December 25, 2021. If none of the nominees or self-nominees is qualified, the Award will not be granted.

--The CHUS Board will announce and present the awards at AHA Annual Meeting in January 2022

V Call for Graduate Student Travel Grant Application
